IMPORTANT DATES



- **DUE DATE FOR REQUIRED DOCUMENTS** March 19th, 2024. After this date, documents will not be accepted.
- **REGISTRATION** To participate in this Summer 2024 admission process, candidates should enter to:
https://ares.cio.mx/CIO/SCCIO/ficha_esp_ext March 19th, 2024. After this date, candidates won't be able to enter online.
- **ACHIEVEMENT TEST** April 1st, 2024. This test evaluates the following subjects: Mathematics, Physics, and English. It is important to be prepared before the tests, and a study guide will be sent after the registration.
- **INTERVIEWS (Master and Ph.D. candidates)** From April 17th to 19th, 2024. It will be at our (CIO) facilities, or it also could be through a video call.
- **RESULTS** April 26th, 2024.
- **INTRODUCTORY COURSE** If the admission results show that the candidate must take an introductory course, it must be taken on the following dates: from May 13th to July 5th, 2024; it will be at our (CIO) facilities. The results will be available on July 31st, 2024.
- **MANDATORY ORIENTATION** August 29th and 30th, 2024.
- **REGULAR CLASSES START** September 2nd, 2024.

REQUIRED DOCUMENTS

READ ENTIRELY AND ACCEPT THE TERMS AND CONDITIONS AND THE ACADEMIC CURRICULUM OF EACH POSTGRADUATE PROGRAM.

1. COPY OF BACHELOR'S DEGREE

Candidates must have their bachelor's degree legalized in Mexico to enter the program at the CIO. In case it is still in process, you can upload one of the following documents:

- a) Proof of the certification exam taken to earn the degree.
- b) Proof of degree.
- c) Proof of the presentation date of the exam taken to earn the degree.
- d) Copy of official transcripts from bachelor studies indicating the general grade point average.

2. COPY OF MASTER'S DEGREE

Candidates must have their Master's degree legalized in Mexico to enter the program at the CIO. In case it is still in process, you can upload one of the following documents:

- a) Proof of the certification exam taken to earn the degree.
- b) Proof of degree
- c) Proof of the presentation date of the exam taken to earn the degree.
- d) Copy of official transcripts from master's studies indicating the general grade point average.

3. COPY OF OFFICIAL TRANSCRIPTS FROM BACHELOR STUDIES INDICATING THE GENERAL GRADE POINT AVERAGE

RECOMMENDATIONS

AND STEPS TO FOLLOW IN THE ADMISSION PROCESS

1. ONLINE REGISTRATION

https://ares.cio.mx/CIO/SCCIO/ficha_esp_ext

To complete the admission process, candidates must have completed their bachelor's or master's degree or proof of the certification exam taken to earn the degree.

2. DOCUMENTS

Once the documents have been sent, the candidates will receive an email with their user name and password. Afterward, the candidates will be able to access the system and upload the documents in PDF format. The information of three academic references will be uploaded in the same system.

3. ACHIEVEMENT TEST

This test evaluates the following subjects: Mathematics, Physics, and English. It is important to be prepared before the tests, a study guide will be sent after the registration.

4. ESSAY STATING PROFESSIONAL OBJECTIVES

It is a free format letter where the candidates will express their interests to get the scholarship and why should they be accepted? We recommend that this letter include: date, place, subject, recipient's name (Academic Committee), etc. It is recommended that this letter does not exceed two pages.

5. INTERVIEWS (only Ph.D. candidates)

It will be at our (CIO) facilities or it also could be through a video call, with the academic authorities present, which is very important to respect the assigned time. We recommend you being available one hour before and one hour after the scheduled interview.

6. RESULTS

Candidates will receive an email with the results of the admission process, which could be: Admitted, Admitted with conditional to take an introductory course, or Not Admitted. After being admitted, candidates must wait for the acceptance letter that CIO will send through courier service and then go to the Mexican Embassy or Consulate in their country to get a student temporary Visa.

7. MOVING TO CIO

To the foreign candidates, we recommend you to arrive to the city of Leon, Guanajuato 15 days in advance to be properly installed in the city, locate access routes and check distance times.
